Background

- 1.Slow growth of GC signatory companies: only 60 at 29th Feb.2008**
- 2.Insufficient participations by corporate executives**
- 3.Inactive collaboration among members and with other local networks**

Root cause:

- **Lack of appropriate organizational structure**
- **Absence of full-time secretariat functions**



Major changes and assumptions.

1. Create Principal Members status

- Members who wish to make significant contributions become Principle Members
- Qualified for candidacy and voting right for the Board member.

2. Establish Global Compact Board Japan (“GC-BJ”).

- Maximum of fifteen, from Principal Members, Representatives of NGO and Academia and Japanese (UN)GC Board member, if exist.
- Principal roles are to give overall vision to GCJN and to make decisions on key directional matters.

3. Establish Secretariat Office.

- Small number of full-time staff and several voluntary part timers from the member companies.
- Principle roles are planning, administrative matters, entry point for new participants, promotion of initiatives, outreach, etc.
- UNIC no longer serves as secretariat, but provide external assistance.

4. Annual membership fees.

- Base Membership fee (all members):
50,000 yen/year for SMEs , 100,000 yen / year for large companies.
- Principal Members (New):
500,000 yen/year for SMEs, 1,000,000 yen/year for large companies.



CEOs of CG-JN committed to New Structure as Board members

Establish Global Compact Board Japan (“GC-BJ”)

with 5 CEOs and 5 people of experience or academic standing

- 1) Board meeting : 3 times / year to supervise over all of GC-JN

with ¥3,000,000 member fee .

c.f. regular member fee: ¥100,000

- 2) Board foster CSR management in next generation

‘Asuno Keiei wo Kangaeru kai’ with 9 young leaders from GC-JN member

(AKK: thinking over tomorrow’s CSR management)

monthly workshop with lecture and discussion for CSR management



Establish **Secretariat Office** with **Principal Members** and some other members who shows its involvement to GC-JN

1) Welcome Campaign with GCO

Send letter to 100 CEOs of major companies to invite Global Compact, having guidance to participate GC and GC-JN

2) Coordinate 3 sub committee

a) Global warming

b) Supply chain of Asia

c) Case study

GC-JN member has to join at least one sub committee

3) Collaborate with multi stakeholder

a) symposium with UNEP-FI on 19th Dec.

b) internal seminar with The World Bank group

c) participate UN day event with UNIC
