- ✓ **GC Moldova - launched on November 28th, 2006**
- ✓ **counts 41 companies and associations**
- ✓ **coordinated by UNDP Moldova office**
- ✓ **lead by the Council of Coordinators, 7 members, 1 year mandate**
- ✓ **adoption of network Regulation (Feb. 7, 2008)**



# Public utility initiative – joint best practices

- ✓ **“Green Day –for we care”** , 170 people from 13 companies- GC members were involved in voluntary works in the capital public garden (April 12, 2007).
- ✓ **Works done:** plant of lindens, painting of benches, raking of leaves and picking up the leaves, digging tree beds and sweeping alleys
- ✓ **Lesson learned:** slow found raising due to a lack of network financial and fiscal mechanism money found to be created for the easiest
- Impact:** GC awareness increased, members solidarity improved, wide post PR resonance, replicable example offered for the business community of RM



# GC & Parliament of RM – dialogue establishment

- ✓ **Round table** “CSR and the role of everyone in promoting the concept for the well-being of the society populating the Rep. of Moldova” (July 7, 2008).
- ✓ **Attended by the:** Chairman of the Parliament of RM, Mr. Marian Lupu, the representatives of the Moldovan Government (Vice-Ministers of the Ministry of Finance, Justice, Social Protection, etc.), as well as the exponents of non-governmental sector.
- ✓ **Results:**
  - adopted round table Resolution
  - elaboration of initiatives to be jointly discussed and implemented
  - elaboration of inter-collaboration mechanism/ quarterly joint meetings
- ✓ **Joint actions:**
  - informative visit to two penitentiaries for minors Lipcani and Solonet to search for social integration of the liberated youth (August 13<sup>th</sup>, 29<sup>th</sup>)
  - co-organization of the Int. CSR conference in Moldova (October 31<sup>st</sup>)



# Code on child labor elimination - initiative

- ✓ Moldova background - child labor used due to:
  - labor force emigration abroad (app. 1 mln of population)
  - big number of children living alone from their parents

## Actions:

- **IPEC presentation** at the trimester general GCN meeting
- participation at the working session organized by the National Council of Syndicates and Patronage of Moldova & ILO-IPEC, dedicated to celebrate the **Int. day of child labor abolition** (June 12th)

- ✓ **To be done:** Elaboration and signing by the GCN members of the **"Code on child labor elimination"**
