The Moroccan network of the Global Compact

October 2007

The Moroccan network of the Global Compact was created by the project "Sustainable Development thanks to the Global Compact" that is funded by the Italian Ministry of Foreign Affairs and implemented by the International Labour Organization (ILO).

The project promotes an integrated approach to sustainable development based on the principles of the Global Compact, the ILO Tripartite Declaration concerning multinational enterprises and social policy, and the OECD Guidelines for multinational enterprises in four countries: Italy, Albania, Morocco and Tunisia. Its specific goals are to encourage the adoption of business practices based on the principles of the three instruments and to facilitate the creation of Global Compact networks and public-private partnerships.

The ILO tripartite partners oversee project implementation through steering committees made up of representatives from the relevant Ministries and the main organizations of employers and trade unions of every country of operation. Tripartite steering committees have been set up in the four countries in order to ensure that the implementation of the project takes into account the national realities and constituents' concerns. These committees also act as Steering Committees of the Global Compact Network in each country.

Network objectives and priorities

The project "Sustainable Development thanks to The Global Compact" in Morocco was focusing in its second year of activity on:

- Raising awareness about CSR within companies, unions and inspectorate of labour.
- Participating and organizing conferences on CSR at national and regional level
- Pursuing companies to sign the Global Compact and sharing their experiences with others
- Organizing training for Training officers from different organizations represented in the steering committee on labour aspects of CSR. Participants will organize trainings in their organizations.

Organization

The focal point of the project Sustainable Development thanks to The Global Compact is assuming the management and the advertising of all the information coming from the Global Compact Office.

The Moroccan Steering Committee comprises of the following institutions and organizations:

- Italian Embassy in Morocco

The steering committee held two meetings during the year (January 29th and September 6th).

Participation

Companies are only represented by the Moroccan business association, because the project was launched by the ILO, and for this reason there is a tripartite representation (government, Ministries of Employment, Environment and Business).

The government is represented by the ministries those are directly concerned by CSR and specifically the principles of The Global Compact.

Activities

The project is playing its role as a promoter of the Global Compact at the local level. The information campaign started in March 2006 with the publication of the project brochure in French and Arabic and the website in French, Arabic and English (www.pactemondialmaroc.org).

Information seminars have been organized for the Moroccan organizations of employers and workers and the labour inspectorates in Casablanca, Tangier, Fes, Marrakech, Mohammedia and Agadir.

The project provides assistance to companies and other organizations that wish to adhere to the Global Compact, to know more about its principles or to join and form networks. It also assists its participants, whenever needed, in carrying out concrete actions to implement the principles of the ILO Tripartite Declaration and collaborates with the Italian National Contact Point and the Trade Union Advisory Committee (TUAC) for matters related to the OECD guidelines. Also the news coming from the GCO are translated to French and Arabic, and added consequently to the News section of the website.

In Morocco, the number of companies that signed the Global Compact remains modest (less than 10 companies).

The Focal Point of Tunisia organized a Workshop on COPs in April, and a Moroccan manager of the focal point was invited to lead this event. A similar event would be organized by the Moroccan focal point in the next months.

From the starting up of the project, the countries involved in (Italy, Tunisia, Morocco and Albania) pursued their partnership in exchanging information and experiences. An important component of the project is the organization of training seminars to help companies integrate labour principles in their strategies and operations. The project is developing a training manual on how to put in practice the labour principles of the MNE Declaration, which include the Global Compact principles. The introductory module provides an overview on CSR and its main instruments and initiatives, while the following modules each cover a specific labour-related subject: industrial relations, equality of opportunities and treatment, child labour, forced labour, occupational safety and health, skills training, and employment. The materials are currently being translated into Arabic. Courses are expected to start in the end of October 2007.

Moreover, training on Labour aspects of CSR was launched in the ILO's International Center of Training (Turin, Italy) from the 2nd to the 6th of July 2007. Participants from these different countries participated in this event and exchange their mutual experiences and views.

Globally, the project participated in many national and regional events on CSR to raise awareness about the Global Compact. The seminars and conferences

on the Global Compact gather managers of companies, representatives of trade unions and labour inspectors¹.

The focal point carries out the role of intermediary between the GCO and the different stakeholders through all the communication tools (website, mailing and meetings). In some events, GC participants are invited to share their experience with other companies and institutions. An SME is invited to present its story and share its experience during the day of standardization, the 17th of October, where the project will be represented.

The majority of companies that participated to the GC were approached during the year. The most important participation of the year is from the Moroccan business association that signed the GC and launched a CSR charter.

This project will finish in December. A meeting with companies participating to the GC will be organized before this date to evaluate the possibilities of launching a permanent representation (association, network...). In the last meeting of the steering committee (September 6th), members were invited to think about possible leads.

Until now, the network had been managed by the ILO and its form will change for sure before the end of the project in December. Companies participating to Global Compact will be invited to think about the future of the project, and the possibilities of creating a new institution that will manage the focal point.

Progress

The project achieved the majority of the objectives stated by the steering committee and the general framework of the project. The real drawback of the project still represented in the modest number of companies that joined the Global Compact, but that's challenge is probably being confronted by the membership of sectoral federations and business associations. The setting up of the CSR Charter by the main business association in Morocco (CGEM) is pushing companies to react and know about the Global Compact and CSR in general.

Until the end of the project, probably by the end of 2007, it will continue to organize activities and provide assistance to the GC network. During that time, the project will prepare the steering committee and the members of the network to continue functioning afterwards.
