What's been achieved

- > Programme begun August 2006
- > Members conduct Peer Reviews 4 times a year
- > 3 possible outcomes
 - > Compliant
 - > Compliant with qualification
 - > Non-compliant with reasons

What's been achieved

- > Aim is to have 50% of Network's COPs reviewed each year
- > Five reviews conducted since 2006
- > 19 CoPs reviewed
- > Two reds helped to green

The review results

17 members reviewed:

> Green 7

> Amber 7

> Red 3 > 2 so far re-reviewed > Green
